# Risk Assessment of PECsoil in the Evaluation Procedure in Europe

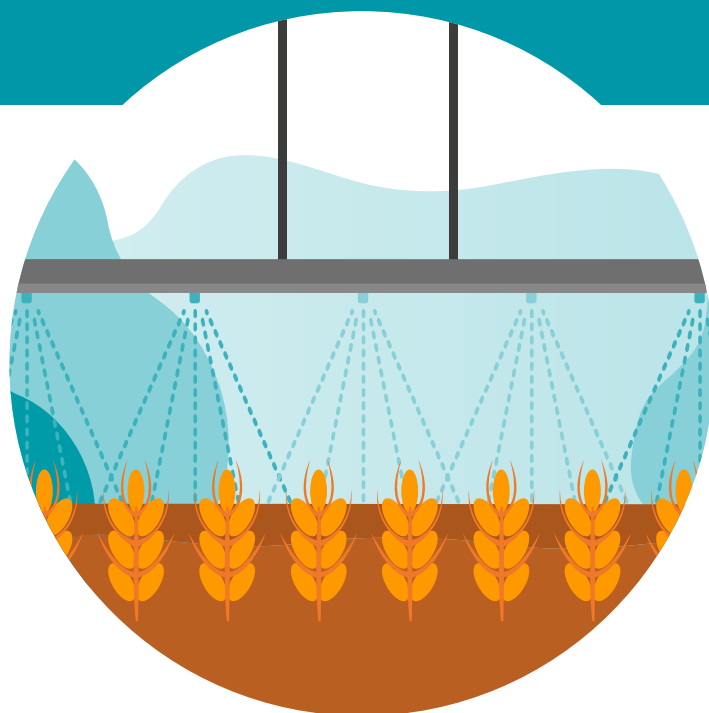
