Terms and Conditions for Exhibitions

1. Organiser

2. Registration

Written registration requires details of the exhibition participants (name, function) and the exhibiting company (company name, address) under acceptance of these terms and conditions of participation. Upon receipt of your registration, you will be sent a letter of acceptance. Exclusivity cannot be guaranteed.

3. Assignment of Space and Changes

Special requests for space are considered wherever possible. However, our exhibitors have no claim to a specific location. The organiser reserves the right, wherever necessary, to relocate assigned spaces or to make slight changes to stand sizes. The organiser also reserves the right to move the entrances and exits to and from the conference area as well as to move passageways.

4. Terms of Payment

All exhibition fees shall be paid prior to the event. Discounts cannot be accumulated. All amounts shall be remitted without deductions.

5. Cancellations

Written cancellations can be made free of charge by fax, email or postal mail up to four weeks prior to the event. After this period and up to one week before the fixed date, 50% of the fee shall be refunded. Once the aforementioned period has elapsed, no refund shall be issued.

6. Sales Regulations

Open sales, including samples, are not permitted.

7. Advertising in the Event Area

Advertising media may only be displayed or distributed within the rented stand area. The organiser is entitled to prohibit the distribution and display of advertising media which may give rise to complaint or cause offence and to confiscate existing supplies of this advertising matter for the duration of the event. Care should be taken that the location or style of any advertising media does not interfere with neighbouring exhibits. The organiser may intervene and request alterations in the event of a violation of this regulation.

8. Technical Services

The booking of exhibition space does not include exhibition materials (exhibition booths, display walls, etc.). In the case that a high-voltage power connection is required, this should be stated at the time of booking. Tables, chairs and a power connection can normally be made available upon prior arrangement with the conference hotel. Additional equipment should be ordered by the exhibitor from the conference hotel or elsewhere. The installation and dismantling of the stand are to be organised by the exhibitor. The exhibitor shall be liable for any damages arising from the aforementioned activities.

9. Cleaning

The cleaning of the stand is the responsibility of the exhibitor. In particular, any materials left over after the dismantling of the stand must be disposed of appropriately. Any disposal costs incurred will be passed on to the exhibitor.

10. Exclusion of Liability

The organiser accepts no liability for the exhibition objects and materials.

11. Changes

The organiser is entitled to shorten, change or postpone an event with good cause. This shall not entitle the exhibitor to terminate the contract, request a reduction in the price or seek compensation. In the event of the cancellation of an event, for example due to low participant numbers, any prepaid fees shall be refunded.

12. Domestic Authority

The organiser shall exercise domestic authority in the entire event area during installation and dismantling as well as during the actual event. The organiser is entitled to issue directives. The organiser also reserves the right to regulate competition.

13. Verbal Agreements

All agreements, individual and special authorisations require the express written confirmation of the organiser.

14. Statute of Limitations

All claims against the organiser must be made within one year of providing the services. This does not apply to cases in which the statutory period of limitation is shorter.

15. General Regulations

Should specific regulations within these terms and conditions of participation be wholly or partially void, the other regulations remain unaffected. The legal venue and place of performance is Dortmund unless otherwise agreed in writing.
